In September 2007, the San Bernardino County Homeless Partnership (SBCHP) was formed to provide a more focused approach to our goal of ending homelessness within the County. The Partnership consists of city governments, community based organizations, faith-based organizations, educational institutes, non-profit organizations, private industry, and federal, state, and local government.

SBCHP was developed to promote a strong collaboration between agencies to direct the planning, development, and implementation of the County's 10-year-plan to end chronic homelessness. The Partnership meets on the third Wednesday of each month at the Behavioral Health Resource Center in Rialto. The Partnership facilitates better communication, planning, coordination, and cooperation among all entities that provide services and/or resources for the relief of homelessness in San Bernardino County.

Mission Statement

The Mission of the San Bernardino County Homeless Partnership is to provide a system of care that is inclusive, well planned, coordinated and evaluated and is accessible to all who are homeless and those at-risk of becoming homeless.

Call to Order Welcome and Introductions	Don Smith	<ul style="list-style-type: none"> ▪ The meeting was called to order at 1:07 p.m. Attendees were welcomed to the meeting and asked to introduce themselves.

Updates from representatives on progress of regional meetings	Jessica Alexander Central Valley	<ul style="list-style-type: none"> • The Central Valley finally had a quorum and Jessica Alexander was officially voted in as Central Valley Chair. • They continued the discussion regarding homeless students within college campuses. • Tom Hernandez and Kent Paxton presented on HEAP and asked for input from the attendees on what criteria they feel should be set for the HEAP and CESH funds.
	Wendell Wilson Mountain	<ul style="list-style-type: none"> • The Mountain Homeless Coalition has been in existence for just over a year now and our big project this year was supplying school supplies and backpacks to the homeless children in our community. We have 131 designated homeless children in our school district. • We are working with the County of San Bernardino to get a full time Social Worker/ Navigator to be assigned to the mountains.
	Jimmy Waldron Desert Region	<ul style="list-style-type: none"> • We've had some scheduling conflicts the last couple of months so we haven't had any meetings. We are hoping to get back on track in December. • We are in the process of purchasing a building for the Victor Valley Warming Shelter. The city of Victorville has funded us for a modular building that will be put on the Fairgrounds property that we lease. • They also are providing 40 bunk beds with mattresses which means we will have 80 beds available. • We met with various churches to see if they would like to get involved and volunteer at the warming shelters. We will provide training for volunteers and hopefully have the warming shelter up and running by mid-November. • The warming shelter will open when the weather is forecasted at 40 degrees or less. We open from 6pm to 6 am.
	Lakita Johnson East Valley Region	<ul style="list-style-type: none"> • The Morongo Basin now has its very own Crisis Residential Treatment facility (CRT). This is huge for the Basin as we can now treat people locally rather than have to send them down the hill. • The CRT is a safe place to treat clients that may be having a break down or psychiatric episode. It's a residential program of up to 30 days for individuals ages 18-59. • If anyone is looking to do services in the Morongo Basin I encourage you to look at the Morongo Basin Haven as we are looking for new members with innovated ideas. Please see me for more information.

On the agenda we had the approvals for Administrative Entities (AE) for both the State of California Emergency Solutions and Housing Program (CESH) and Homeless Emergency Aid Program (HEAP). • ICH approved Community Development and Housing Agency as the AE for CESH and the Office of Homeless Services for HEAP. • Kent Paxton and I also presented the recommend priorities that we gathered from the regional HPN meetings and asked that they adopt these priorities as we move forward in the application process. • Some of those priorities include: <ul style="list-style-type: none"> ○ Emergency Shelter Beds ○ Bridge Housing ○ Street Outreach ○ Diversion/Prevention ○ Document Readiness ○ Re-cooperative Care Projects ○ Case Management ○ Hotel-Motel Vouchers • The CESH application is due this month. Community Development and Housing Agency submitted our application on October 5, 2018. • The Request for Application is open for the HEAP funds. • October 24th is the next ICH meeting. At this meeting they will be appointing a special Grant Review Committee for the HEAP applications. • The office of Homeless Services is currently working on the Point In Time Count (PITC). The cities have already started appointing their contacts. As you know each city does their own count we just assist in facilitating. If you would like to know who the contact is for your city you can contact Michele Bletcher at (909) 386-8231. • The Homeless Summit is coming up on November 14th. It will be held at the Ontario Airport Hotel. Registration begins at 9:00 a.m. the event begins at 10:00 – 3:30pm. This year's theme is Aspire to Inspire. 	<p>Marcela Manzo CoC Coordinated Entry System</p>	<ul style="list-style-type: none"> • As of the end of September we have housed with our partners about 630 households since January 2016. • We have 75 people in the pipeline that are enrolled with a housing provider. • There are 312 individuals currently out for referrals. • Right now we CES is currently on a call back schedule of 5-7 days. We only have three staff members that answer phones, take assessments, and do street outreach. We are looking to expand as we have had in influx of calls coming in. • If you are a program that needs referrals please contact me. We can get you connected with CES and train you in HMIS. • If your agency is not receiving referrals from CES please make sure your information is correct.

Housing is a right. 45% of the residents in San Bernardino County do not make enough money to pay rent. 1 and 33 have been evicted. San Bernardino is the second highest county of evictions in the state. The ACLU offers litigation services, meditation and advocacy.

The Victor Valley Warming Shelter will open in November and run through March. Our biggest need is man power. We need volunteer s to help run the shelter. The shifts are from 5-10pm, 10-3:00 am and 3-8 am. We are working on stream lining our check-in process. We are looking at having a 10:00 pm check-in cutoff unless a person is brought in by law enforcement.
