Funded by the offices for Innovation. Is an alternative to the DBH’s Laura’s Law programs. The target population are adults who are not yet connected to services due to impaired insight into their mental illness. May have co-occurring substance abuse. Primary focus is homeless or at risk of homelessness. They use a LEAP approach (Listen, empathize, agree and partner) with holistic interventions which build trust with the client and link them to resources and services to improve their quality of life. Ability to pay is not an issue. Referrals into the program may come from any source. Flyer was distributed. <p>Old Business, New Business, Roundtable:</p> <ul style="list-style-type: none"> • PITC – ICH may release tentative numbers soon. Possible update next month. • Grant Committee – Haven has decided to start looking at ways to provide additional help in the community. Talks are underway about possible small, criterion based monetary grants to programs to help clients maintain stable housing or obtain necessary services or supplies. Liz, Shelly, Wayne, Sharon and Heidi to be body of the committee. A first report will be presented at the next meeting. • SOAR – SOAR is a SAMHSA, SSI/SSDI Outreach, Access and Recovery program.
