Homeless Provider Network	Sharon Green Tom Hernandez Sharon Green	 The last HPN Meeting took place on Wednesday, May 15, 2013. An HMIS update was provided by Jim Rosemeyer. Training for HMIS users and administration reports began this month. A schedule was sent out by the Office of Homeless Services. All agencies providing services to our homeless population should already be using HMIS. Union Pacific Railroad Foundation came to advise that their funding period is now open. Agencies are encouraged to apply. Ms. Lupe Valdez stated that agencies should keep fund requests under a maximum of \$15,000. You can find their grant application on their website at www.up.com. To add to this, last year Union Pacific funded over 125 grants to the San Bernardino area. A Point-In-Time Count update was provided by Don Smith. The preliminary report is available on the Office of Homeless Services website at www.sbcounty.gov/SBCHP. Agencies are encouraged to use this report as a baseline to set objectives to end homelessness in our communities and in setting goals. The next meeting will be on Wednesday, June 19, 2013 from 1:00pm to 3:00pm. The location will be at County of San Bernardino Health Services at 850 E. Foothill Blvd. Rialto, CA 92376. 		
Office of Homeless Services	Tom Hernandez Lisa Jones	 The ICH members were provided with the OHS Report as a hand out with attachments. (Copies are available upon request). All information can also be found at <u>www.sbcounty.gov/SBCHP</u>. The Rapid Results Veterans Boot Camp will be held in Los Angeles at the Double Tree by Hilton Los Angeles on June 4th through June 6th. Each day will start at 8:30am and end by 5:00pm, except June 6, 2013, which will end at noon. It is being sponsored by The U.S. Department of Veterans Affairs (VA), the U.S. Department of Housing and Urban Development (HUD), and the U.S. Interagency Council on Homelessness (USICH) as part of their commitment to reducing veterans' homelessness. The goal of the VA, HUD and USICH is to help communities craft solutions and strategies that will have the greatest impact locally, on reducing veterans' homelessness. The County of San Bernardino has been selected to be one of only twenty (20) communities that will participate in this training. The Office of Homeless Services is serving as team lead for approximately 12 individuals that will represent the San Bernardino County Homeless Partnership including members from the VA, Housing Authority, OHS and various other homeless service providers. Ms. Jones announced that the Housing Authority did receive their conditional award, which basically means they got an additional 55 vouchers for Veterans VASH Program.

Tom Hernandez	 Ann Oliva, Director of the Office of Special Needs Assistance Programs from HUD issued a letter providing an update on initiatives and key issues that will impact the Office of Special Needs Assistance Programs (SNAPS), Continuum of Care (CoC) and Emergency Solutions Grants (ESG) recipients (see attached Report 2A). Of note in the letter is the following: ****CoCs and CoC Program recipients should expect the FY2013 CoC Program Notice of Funding Availability (NOFA) to require cuts exceeding the 3.5% that they had to plan for in FY2012. Based upon HUD's preliminary projections, the FY2013 agorpropriation for the CoC Program will not be enough to provide funds for all existing renewals and those renewing for the first time in 2013. Regrettably, HUD is suggesting that CoCs begin planning now about how they could best implement these cuts by making strategic local decisions. More information will be provided in the FY2013 CoC Program NOFA when it is released.* Also of note, the letter provided planning points to each community to assist them in prioritizing needs and services to maximize efficiency. On Thursday, May 2, 2013, HUD Secretary Shaun Donovan announced the second round of renewed support for more than 500 local homeless housing and service programs across the U.S. The \$72 million (\$72,189,033) for the Tire 2 renewal competitive programs for a total of \$1.61 billion (\$1,614,639,880). The Tire 2 renewal amount for our CoC of \$4,306,308. HUD intends to announce the new projects within the next 40 days. The announcement will include new projects that pass the threshold scoring for project sublitications that are included in a CoC that scores at a minimum of 97 points out of 130 points. The Bureau of Justice is giving out a Second Chance Grant, a Two-Phase Planning and Implementation. In 2011, the County completed the Planning Phase of it. One of the issues that this grant specifically targets is to give priority to those organizations that deals with homelessness. As you seen in the Point-In-Time Count, 22% of the homeless were recently incarcerated within 12 months. Mr. Marin feels we are strategically well positioned to get the funding. The grant is due on June 20th. They are currently working on developing a Pre-Release Task Force to concentrate on 3 major components including: strengthen pre-release activities, deal with post-release activities and include case management and housing.

They have appointments scheduled out until November. There is currently a three (3) week turnaround. The clinical assessment must happen first. They have to be accepted to DBH in need of services that DBH provides. They also have to meet the HUD definition of disability, including head of household.  - The HMIS Advisory Committee had its quarterly meeting on June 10, 2013 from 9:00am to 11:00am. The Advisory Committee reviewed the modified HMIS user forms as well providing input for the user guide "cheat sheet."
- HMIS End-User Committee
 - HMIS End-Users have been meeting to discuss training and review the required HUD data and program elements, including data security and user responsibilities. An issue that was brought up was the amount of time that it takes to enter and exit clients from the HMIS.
 - To date there have been 3 End-User Trainings and 1 Reports Training.
- HMIS MOU Template
 - On June 18, 2013, a Board Agenda Item was approved by the San Bernardino County Board of Supervisors to approve establishing Memorandums of Understanding (MOU) between Department of Behavioral Health (DBH) and Homeless Services Provider Agencies for the Homeless Management Information System.
 - This MOU will provide a basis for effective utilization of the HMIS. The MOU allows DBH, Office of Homeless Services to review homeless services provider agency performance, and ensure compliance will all applicable and federal and state requirements, including protection of client privacy and confidentiality.
 - This will allow adherence to HMIS Policies and Procedures, including the necessity of compliance will all necessary HUD required data elements for reporting performance measurement and outcomes, and sharing of basic data elements with other agencies to assist homeless clients in the coordinated and comprehensive provision of services.
