<p><i>Land Use and Zoning Ordinances Update:</i></p> <p>Each Regional Area is evaluating the Land Use and Zoning Laws of each city. One region of concern is the Morongo Basin region that has an eight bed facility to meet the need of those experiencing homelessness. Numerous agencies have attempted to open up additional beds. However, each is experiencing roadblocks in doing so.</p> <p>Victor Valley Family Resource Center challenge with the Zoning and Land Use laws of Hesperia made Front Page Headline news of L.A Times on September 14, 2016. Calls have been received from Housing and Urban Development (HUD) and Department of Justice (USDOJ) that they are watching this case closely.</p> <p>HUD has developed additional guidelines for the cities to remain in compliance with Fair Housing Laws concerning those returning home from incarceration. Please read attachment A which is included for this council's records and has been provided to the HPN members.</p> <p>A Preliminary Injunction was filed and granted against Code Enforcement that was citing each Transitional House \$1000.00 a day. The case is still open and an update will be provided once a settlement exists.</p>

Continuum of Care Application Submission Update	
<ul style="list-style-type: none"> • The OHS has submitted the Continuum of Care (CoC) application on September 12, 2016, with a U.S. Department of Housing and Urban Development (HUD) due date of September 14th. • In addition to the Consolidated Application, 25 Project Applications were submitted for a total request of \$10,777,756 in homeless services funding. The application was approved for submittal by the ICH on August 24, 2016. • The total renewal amounts submitted was \$9,156,498. New applications through reallocation and bonus funds were submitted in the amount of \$1,284,656. An application for CoC planning funds was submitted in the amount of \$336,602. • The planning grant may be used to improve performance and collaboration within the San Bernardino County CoC structure, assist in the further evaluation of CoC and ESG programs, conduct annual Point-In-Time Counts (PITC) with increase city participation and ownership, the joint development and planning of local consolidated planning efforts, and the development of the local CoC system to address ending homelessness within various subpopulations within the region.

Redlands Project Connect

- The San Bernardino County Homeless Partnership will be hosting the Redlands Project Connect on Wednesday, October 19, 2016 from 10 am – 2 pm at the Redlands First United Methodist Church, located at 1 E. Olive Ave., Redlands CA 92373.
- The event will be offering services such as medical screenings, veteran services, housing information, and much more from over 40 vendors. There are currently 19 vendors registered for the event. Lunch will be provided by Hogi Yogi. The Diocese of San Bernardino, Asian-Pacific Ministry is also donating non-perishable food to be given away at the event.

Housing First Training

- The San Bernardino County Homeless Partnership in collaboration with the San Bernardino County Advisory Board to End Chronic Homelessness co-sponsored a Housing First Training on September 23, 2016, with guest speakers, Dr. Sam Tsemberis, Tod Lipka, and Philip Mangano, hosted by Loma Linda University at the Centennial Complex's Small Amphitheater. The event was attended by approximately 200 individuals from various providers throughout the Inland Empire.
- Dr. Tsemberis is a clinical-community psychologist and serves on the faculty of the Department of Psychiatry at Columbia University Medical Center. He has also serves as principal investigator for several federally funded multi-site studies of homelessness, mental illness, and addiction, and has published numerous articles and book chapters on these topics.
- Dr. Sam Tsemberis is best known as the founder of Pathways to Housing, which operates programs in New York City, Washington D.C., Philadelphia, and Vermont. Pathways developed the Housing First model that provides immediate access to permanent supported housing; independent apartments and intensive treatment and support services for individuals who are homeless and who have psychiatric disabilities and substance use disorders. The program uses a person-centered harm reduction approach and does not require participation in treatment or sobriety as a precondition for housing.
- Pathways' Housing First is recognized by the U.S. Substance Abuse and Mental Health Administration as an evidence-based practice, having been successfully replicated and evaluated in numerous settings across the United States. Additionally, the program has received recognition and numerous awards including the American Psychiatric Association's Gold Award in the area of community mental health.

**ICH Housing Sub-Committee
Permanent Supportive Housing (PSH)
Five-Year Strategic Plan
9-19-16 Meeting Notes**

Agenda Topics:

1) Review PSH Five-Year Strategic Plan Executive Summary

Except for the addition of some local community-oriented service providers that have development capabilities, the ICH Housing Sub-Committee felt that it has taken the strategic plan as far as it can without getting additional input and direction from the entire ICH governing Board.

2) Report on meetings and discussions with the Housing Authority of the County of San Bernardino (HACSB).

Housing sub-committee chair Ray Osborne reported that he had met with HACSB management staff to present the PSH Five-Year Strategic Plan Executive Summary, as well as to get their input on the work to date and how they think we should proceed.

3) Report on meetings with National Community Renaissance (CORE) and Wakeland Housing Group.

Ray Osborne reported to the sub-committee that he has met with CORE and Wakeland in separate meetings to present the strategic plan to each of them and get their input. He reported that both companies were impressed by the working that the sub-committee had done on the strategic plan, and expressed their willingness to partner in any way they can with regional and local governmental agencies as well as service providers to source funding to develop and build the more than 2,000 PSH units that will need to be constructed in the Inland Empire during the next four years in order to end homelessness in the two-county Inland Empire by 2020.

4) Suggestions, ideas and comments

The sub-committee discussed and formulated four specific action items that they would like ICH to take to continue to move forward with the plan to develop additional PSH units.

Action Items:

1) Ask ICH to adopt the work-to-date Five-Year Strategic Plan Executive Summary.

2) ICH should direct the sub-committee to work with Tom Hernandez and his staff to develop a marketing tool highlighting the issues mentioned in the Executive Summary to be used to attract affordable housing developers and funding sources to create additional PSH units.

3) Ask the Office of Homeless Services to provide a list of the various state and federal funding sources available to develop and construct additional PSH units.

- 4) Stage a Permanent Supportive Housing Summit to encourage all the local jurisdiction, developer and various funding source stakeholders to get together to discuss what is needed immediately to be able to develop at least 1,000 additional PSH units in San Bernardino County by 2020.**

**FIVE-YEAR STRATEGIC PLAN
TO DEVELOP PERMANENT SUPPORTIVE HOUSING (PSH) INVENTORY
NEEDED TO HOUSE THE INLAND EMPIRE HOMELESS POPULATION**

EXECUTIVE SUMMARY

THE PROBLEM

Inland Empire has a serious housing crisis. Every day there are thousands of individuals and families in San Bernardino and Riverside counties who don't have the financial resources, often due to circumstances beyond their control, to be able to afford a place to live. As a result, they have to share inadequate living space with family, relatives or friends, live in their car, and even worse, be forced to live on the street, in parks, under overpasses, or other places not fit for human habitation.

Lack of a good paying job, the need for job skill training, as well as, in some cases, the need for other social service assistance, including various types of counseling, are among the primary barriers to many Inland Empire area residents not being able to have a place to live. However, **the major obstacle that exists in both San Bernardino County and Riverside County is a lack of basic housing inventory, particularly in entry-level and affordable rental units.** California Apartment Association data shows that the vacancy rate in the Inland Empire is less than 3%.

THE HOMELESS POPULATION NUMBERS

According to the 2016 Point-In-Time (PIT) count, conducted independently in both San Bernardino and Riverside counties, there are on a daily basis more than **4,000 men, women and children in the Inland Empire that cannot afford an adequate place to live in our community.**

The annual count statistics show that there are **2,165 homeless individuals in Riverside County, including 1,351 unsheltered and 814 temporarily sheltered. In San Bernardino County, the total number is 1,887, with 1,191 unsheltered and 696 temporarily sheltered.**

The good news is that both counties reported a **12% decrease in the homeless population in 2016 over 2015.**

However, at the current rate of reduction, **it could take more than eight years to house the population that experiences homelessness on an annual basis without an adequate place to live in the Inland Empire area.**

The Riverside County homeless population is concentrated in six primary geographic areas: **Riverside (258), Perris/Hemet/Temecula (209), Indio/Coachella (129), Jurupa Valley (113), Palm Springs/Cathedral City (110), and Corona (83).**

In San Bernardino County, the same population demographic is centered in four specific areas: **San Bernardino (564), Upland/Ontario/Fontana (499), Victorville/Barstow (344), and Redlands (148).**

THE PERMANENT HOUSING INVENTORY CHALLENGE

The major challenge that must be overcome is **a significant lack of permanent housing** throughout the Inland Empire to provide an adequate, affordable place to live for the vast majority, more than 60%, of the current homeless population.

There are a total of **1,297 emergency and transitional living beds (including hotel vouchers) as well as 1,025 permanent supportive beds in Riverside County, and an additional 200 emergency beds and 1,727 permanent supportive beds in San Bernardino County.**

Most of the permanent supportive housing (PSH) units in both counties are already devoted to serving low income barrier families, as well as physically and mentally disabled individuals who will require various supportive services on an ongoing basis.

More than 2,400 individuals annually, primarily single men and women, still need permanent housing in the two-county area.

There is a critical need to develop, either by renovating existing units or building new units, **at least 2,200 permanent housing units throughout the Inland Empire**, the majority of which should be one-bedroom or studio floorplans.

NEED FOR PERMANENT HOUSING CONSTRUCTION RESOURCES

While both San Bernardino County and Riverside County, as well as several local jurisdictions, have strong and effective Housing Authority and Housing Development operations, **there are not enough construction and operational entities that can actually build the permanent housing inventory needed in the Inland Empire.**

The Housing Authority of the County of San Bernardino (HACSB) has a non-profit development operation, **Housing Partners 1**, whose mission it is to acquire land and develop new permanent housing units as well as the acquire and rehab existing housing units. In addition, there are local agencies like the **Riverside Housing Development Corporation (RHDC)** and the **Coachella Valley Housing Coalition** that can develop new housing units or rehab existing housing units.

There is only one non-profit organization, the **Building Industry Association (BIA) HomeAid Inland Empire** charitable operation, whose sole mission is to renovate or build homeless shelter facilities in San Bernardino and Riverside counties.

Development and construction companies, like **National Community Renaissance (CORE), Wakeland Housing, Chelsea Investments, Related Companies, and Metta Corporation**, have varying presence levels in the Inland Empire focused on creating and building large scale affordable housing projects in the two-county area. In addition, there are several local Community-Oriented Service Providers like the **Time For Change Foundation, Mercy House, Lutheran Social Services (LSS), and Salvation Army** that have development capabilities and are willing to partner with development and construction companies like those listed above to create the housing inventory needed to provide men, women and children who need a safe place to live while they work to improve their lives and enhance their ability to be self-sufficient through counseling, education and job training, if sufficient funding resources were available.

CONSTRUCTION FUNDING TO BUILD PERMANENT HOUSING IS LACKING

While there appears to be adequate funding available to provide supportive social services for individuals and families who also need housing, **there is a definite lack of funding to build the Permanent Supportive Housing inventory required to house the population in the Inland Empire that does not have the financial resources to afford an adequate place to live.**

Intensive focus needs to be given to finding the public and private funding sources that it will take to build the critically-needed short-term and long-term permanent housing units required to house the more than 2,400 people annually who currently are without housing in San Bernardino and Riverside counties.

The first step in this process will be to determine the amount of funding that will be required to acquire and renovate existing housing units, as well as to acquire the land and build new affordable permanent housing units.

CONCLUSION

An expanded coalition of public, private and non-profit entities throughout San Bernardino and Riverside counties with a well-coordinated mission **to create more permanent housing inventory** for the area must be developed and implemented in order **to make substantial progress during the next five years towards ending the housing crisis that currently exists in the Inland Empire by the year 2020.**

o	<p>On August 24th, ICH approved the Homeless Youth Survey report. The 88-page report concluded with the following recommendations:</p> <ol style="list-style-type: none"> 1. Recommendation 1: Examine Transportation Resources Available for Youth <ul style="list-style-type: none"> • Youth expressed the need for transportation resources to access services such as emergency shelter, food banks, counseling and mental health services, etc. • The Taskforce recommends increasing youth knowledge of free available shuttles in the community such as Molina Healthcare Neighborhood Shuttle. This is a free fixed route adjunct service to the available public bus service for the cities of San Bernardino, Rialto, and Fontana. 2. Would authorize the Department of Housing and Community Development to issue a Notice of Funding Availability under which the director of the department could determine that an applicant previously awarded funds is eligible to apply for, and receive, additional funds pursuant to the Community Development Block Grant Program, without regard to whether the applicant has expended at least a certain percentage of funds previously awarded. This bill contains other related provisions and other existing laws.

Education finance: Safe Neighborhoods and Schools Fund: Learning Communities for School Success Program. This bill, beginning July 1, 2017, would give first priority enrollment to pupils who are identified by the program as homeless youth, as defined, and pupils who are identified by the program as being in foster care, and 2nd priority enrollment, for programs serving middle and junior high school pupils, to pupils who attend the program daily.

Department of Behavioral Health: This item is a **GRANT RENEWAL AWARD FROM THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR THE CONTINUUM OF CARE HOMELESS ASSISTANCE PROGRAM** for the Continuum of Care HMIS funding, in the amount of \$250,158 for the period of November 1, 2016 through October 31, 2017.

Background: DBH has operated the HUD mandated countywide HMIS on behalf of the County of San Bernardino COC since March 2013. DBH will use the grant award to continue providing HMIS data and evaluation for the implementation, training, reporting, and technical support services for homeless service providers with the County COC, and San Bernardino County Homeless Partnership. DBH also uses the HMIS to capture information regarding the homeless and the effectiveness of homeless advocacy programs, as well as measuring the extent and nature of homelessness, the utilization of programs, and effectiveness and efficiency of homeless programs.

Financial Impact: There is a cash or in-kind match required for the COC funds which will be met through the use of MHSF funds (\$31,270) and Human Services Reimbursement (\$31,270).

22. Department of Behavioral Health: This item is a **GRANTAWARD THROUGH THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT FOR THE CONTINUUM OF CARE HOMELESS ASSISTANCE PLANNING PROJECT** in the amount of \$305,672 for a one year period beginning the date of execution by HUD.

Background: The grant funding will be utilized to improve the design of and carry out the collaborative process for the application to HUD: 1) to increase and expand the evaluative outcomes of the COC and ESG programs, including collaborative efforts and alignment of services to identify outreach strategies and improve services, 2) engage local municipalities to participate and assume ownership of the annual Point-in-Time Count, 3) integrate the COC and other homeless funded programs into the consolidated planning process of the local municipal agencies to enhance regional coordination of services, and 4) further the development of the COC system that will assist in the efforts of ending homelessness among veterans, youth, families, and the chronically homeless.

Financial Impact: There is a 25% cash or in-kind match requirement which will be made through MHSA funds (\$38,209) and Human Services Reimbursement (\$38,209).

Community Development and Housing: This item is the **HOUSING AND URBAN DEVELOPMENT CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT, HOME AND EMERGENCY SOLUTIONS GRANT PROGRAMS** conducting a Public Hearing to review the County's performance and accomplishments for the first year of the 2015-2020 Plan.

Background: The HUD Consolidated Annual Performance and Evaluation Report (CAPER) is a federally mandated document that evaluates the County's overall progress and measures its performance carrying out the activities identified in its 2015-2020 Consolidated Plan. Community Development and Housing: This item is the **STATE EMERGENCY SOLUTIONS GRANT AWARD FOR 2016-18** approving a resolution certifying that the County of San Bernardino, Community Development and Housing is authorized and directed to receive the State Emergency Solutions Grant in an amount not to exceed \$610,745 and that the County of San Bernardino and CDH is authorized to administer the State ESG funds on behalf of the State of California Department of Housing and Community Development (HCD) as an Administrative Entity.

Background: The recommended actions will allow CDH to become an Administrative Entity for the HCD and allow CDH to enter into sub-recipient contracts with Catholic Charities (\$200,000), Time for Change Foundation (\$193,935), and Inland Temporary Homes (\$370,000) for the provision of homeless services such as emergency shelter, homeless prevention, rental assistance, rapid re-housing, case management, street outreach, and related counseling services in the cities of Apple Valley, Chino, Chino Hills, Hesperia, Rancho Cucamonga, Rialto, Upland, and Victorville.

Additionally, the leveraged funding will add a new County program for Housing Search Specialists (HSS) which will provide housing search and placement services to help eliminate housing barriers and connect resources to clients, including sustaining landlord relationships.

Financial Impact: CDH will receive a grant award of \$610,745 (\$593,935 for program administration and an approximate 2.75% allocation or \$16,810 for administrative cost.

HACSB and KEYS Inc. continue to expand both resources and results in their respective responses to homelessness.

Current homeless programs and assistance available via HACSB as of August 30, 2016:

- Continuum of Care Permanent Supportive Housing: currently 289 leased, 20 pending lease and we have approximately 26 new turn over openings per year for chronically homeless. Please see the Continuum of Care Utilization report attached for more detail.
- Veterans Affairs Supportive Housing (VASH) vouchers, 331 leased, 10 pending lease, 32 voucher holders searching, and 34 available.
- No Child Left Unsheltered – Project Based Permanent Housing for unsheltered homeless children and their families, 30 lease, 5 pending lease and 15 currently available.
- Homeless Veterans Project Based Voucher program- 12 units committed in Victorville, 11 leased. Forty eight (48) are available for contract. Request for Proposal is posted on our website at www.hacsb.com under the business section.

***Lanternwoods-** Current projections show that there will be unexpended funds at the end of the grant term (11/30/17). This is PRA so there is no ability to 'over-lease' additional units in order to expend grant funds. However, HACSB is in conversation with HUD staff to determine other ways that the funding can potentially be extended or re-allocated with regulatory waivers to ensure funding stays within the county.

Reallocation- In the 2015 grant cycle, HACSB worked with OHS and ICH to identify funds that could be carved out of 3 current grants in order to be utilized for re-allocation. This was done with no impact to currently housed families or in a way that would cause a reduction in current housing resources. This funding helped support the funding that was dedicated to the implementation and ongoing funding of the new Coordinated Entry System. The grants utilized were New Horizons, Stepping Stones and Laurelbrook.

PUC Fluctuations- It is worth note that small changes in household income or changes in contract rent can have significant effect on the average Per Unit Cost and monthly expenditure projections. It is expected to see some fluctuation on a monthly basis and the HACSB staff watches this carefully in order to adjust leasing utilization when funding is available. However, it is also important to note that even if there may be small amounts of unutilized funding projected at the end of a grant term, it is vital to consider that if we lease more households to utilize that funding, that there is enough funding in the *next grant cycle* to be able to support those additional households. As part of our monthly analysis, we not only look at the current grant year and funding availability, but the next grant year and funding cycle.

RECOMMENDATION

Approve the Office of Homeless Services (OHS) to allocate \$25,000 of CoC Planning Grant funds to conduct a cost study analysis related to determining the cost of chronic homelessness in San Bernardino, CA.

BACKGROUND INFORMATION

The Office of Homeless Services (OHS) is requesting the Interagency Council on Homelessness (ICH) to approve \$25,000 in Planning Grant funds to conduct a cost study analysis of homelessness in San Bernardino County. OHS will seek a provider to conduct a complete written report on the cost of chronic homelessness in San Bernardino, CA, using information obtained on current and historical homeless trends and public costs incurred related to chronic homelessness.

The following objectives will be included in a scope of work:

- Projecting the typical annualized costs of homelessness over a 10 year period.
- Contrasting those public sector costs to the savings that could be achieved if those same individuals (or others like them) were in supportive housing with services instead of remaining homeless.
- Projecting the number of units of housing required to end chronic homelessness in San Bernardino through implementation of a community-wide plan for development of affordable housing with fidelity to Housing First and Permanent Supportive Housing.
- Projecting the positive economic impacts related to the development of affordable housing at a scale to end chronic homelessness while preventing additional homelessness.
