- The Crisis Residential Treatment Facility (CRT) will be opening in Junie 2018. This is a crisis stabilization unit for adults who are experiencing a mental health crisis and need a higher level of care than out-patient programs can offer, but do not meet the 5150 criterion. They are planning to have 16 beds and wraparound services (groups, medication management, therapy, case management, social services, life skills, etc.) The client must be voluntary and able to commit to 30-60 days residential treatment. Substance abuse may be part of the treatment but is not the primary criterion for admission. This in NOT a homeless shelter or housing provider.
- Still waiting on final numbers for Point in Time Count. When the results are in they will be distributed among members.
