In September 2007, the San Bernardino County Homeless Partnership (SBCHP) was formed to provide a more focused approach to our goal of ending homelessness within the County. The Partnership consists of city governments, community based organizations, faith-based organizations, educational institutes, non-profit organizations, private industry, and federal, state, and local government.

SBCHP was developed to promote a strong collaboration between agencies to direct the planning, development, and implementation of the County's 10-year-plan to end chronic homelessness. The Partnership meets on the third Wednesday of each month at the Behavioral Health Resource Center in Rialto. The Partnership facilitates better communication, planning, coordination, and cooperation among all entities that provide services and/or resources for the relief of homelessness in San Bernardino County.

The Mission of the San Bernardino County Homeless Partnership is to provide a system of care that is inclusive, well planned, coordinated and evaluated and is accessible to all who are homeless and those at-risk of becoming homeless.

Call to Order Welcome and Introductions	Sharon Green	The meeting was called to order at 1:04 p.m. Attendees were welcomed to the meeting and asked to introduce themselves.

Updates from representatives on progress of regional meetings	Jessica Alexander Central Valley	 At the last Central Valley meeting I was voted in as the chair. 	Jimmy Waldron Desert Region	 We had a couple presentations at our last few meetings in the desert. The Family Assistance Program came out and gave a presentation on their organization and the projects they are working on. They are building a new community park in downtown Victorville. It will have basketball courts and play equipment for the community. The Academy for Grassroots Organization gave a presentation and a workshop on Logic Model. Our next couple of meetings we will be working on collaborations for the Victor Valley Warming Station opening in November. We are looking for ways to work with other organizations and get volunteers to work the warming station. 		
	Lakita Johnson East Valley Region	 The Morongo Basin is getting its first Crisis Residential Treatment (CRT) Center. It Grand Opening will be July 31st from 10:00 a.m12:00 p.m. at 60805 Twentynine Palms Hwy., Joshua Tree, CA. Molding Hearts opened a new location servicing individuals 26years old and older. The Morongo Basin Haven is having a shift in positions and we are looking for new individuals to be a part of the Haven. If you would like more information please contact me at 951-464-8587. 		
	Wendell Wilson Mountain	 The Mountain Homeless Coalition was formed exactly one year ago this month. We are very proud to have made it through our first year. We are working hard to fill the void of emergency shelter on the mountain. Don Smith at our last meeting mentioned to us the Room and Board Coalition and looking further into that concept. Our challenge is to entice landlords to work with us. We are also reaching out with the faith based organizations on the mountain to see how we can collaborate. 		

Don Smith West Valley	 In the West Valley in May we talked about the Point In Time Count (PITC). We saw the numbers for 2018 increase so we discussed that. We also had a presentation from Maricela Manzo on Pathways Home. She talked about their efforts to expand resources and staffing beyond HUD and also diversion strategies. In June we talked about Diversion Strategies and the workshops we had. We discussed ways to work with folks on their immediate housing crisis without having to enter the homeless services network.
Sharon Green Interagency Council on Homelessness (ICH)	 At the Special ICH meeting yesterday, July 9, 2018 we discussed the Governors new funding coming from the state. More information and the details of these funds will be discussed further at future meetings. The Notice of Funding Availability (NOFA) for the Fiscal Year 2018 Continuum of Care Program Competition was released. I encourage you to go to the HUD website and read the NOFA. We established a standing Grant Review Committee. This was a hug victory for us in our efforts of transparency and having more input as to where our dollars are going.
Marcela Manzo CoC Coordinated Entry System	 CES launched in November 2016. Since then we have housed 527 households. So far in 2018 he have placed 156 households into housing programs. We have conducted 2400 assessments and of those 2400 approximately 600 have self-resolved. We assume they have self-resolved because there has been no contact and no documentation that they have re-entered the HMIS system. Our in-flow is between 125-150 households reporting homelessness each month. I have a team of three outreach workers to coordinate and collaborate and search for individuals. In June we launched a new program, the Housing and Disability Advocacy Program (HDAP) where we connect individuals with disabilities to SSI and housing assistance. We currently have eight individuals enrolled. We have the Housing and Search Team also referred to as the HIP Squad. They do a great job of find potential units, so if you are a CoC provider reach out to the HIP Squad for housing referrals for your clients. We started a new veteran's outreach effort with all of the veteran outreach teams. Tomorrow we will be out in the field in the West Valley and the Central Valley helping veterans connect to VA services.
Don Smith SBC Pathways to Housing Network	 Pathways is looking to develop a diversion and prevention component. This will help us in tracking those that self-resolve. Ultimately this will allow us to help those that have the capacity to self-resolve with assistance. We are always looking to identify housing providers including alternative housing options such as room and boards. The Room and Board Coalition is one of our biggest partners and we appreciate the work they do in identifying housing options for us.
Tom Hernandez Office of Homeless Services	 The Office of Homeless Services (OHS) is in the process of compiling the Homeless Youth County Report and should have that complete by the end of the month. As stated before the NOFA was released so we are busy making sure we are ready to submit the application on time. OHS is helping the newly appointed Grant Review Committee compile all of the applications submitted for renewals and for the DV Bonus and Bonus projects for their review. OHS is preparing for the Homeless Summit that will take place November 14, 2018 at the Ontario Airport Hotel. More information on that will be coming out through the HomelessRFP mailbox so save the date

		and look for that information to be coming out soon.	
		• There is also discussion of a Faith Based Summit to follow the Homeless Summit, which is chaired by Ms. Sharon Green. More information will come out as planning progresses.

Approve Minutes from the April 10, 2018 Meeting	Sharon Green	A motion was made to approve the minutes as written. All were in favor, none opposed or abstained.	
PRESENTATION			
ICH Special Meeting Update	Don Smith Tom Hernandez	 At the special ICH meeting on July 9, 2018 the ICH transitioning the Grant Review Committee from an Ad Hoc Committee to a Standing Committee of the Interagency Council on Homelessness and as such subject to the Brown Act Requirements. Grant Review Committee members were selected from current voting members of the Interagency Council on Homelessness. Two of our HPN chairs were voted in as members, Sharon Green and Jessica Alexander. The NOFA was released and in terms of dollars what we are looking at is an estimated annual renewal demand (ARD) of \$10,066,156 and a Preliminary Pro Rata Need (PPRN) of \$12,461,021 which is the amount our county could potentially be eligible for. HUD only guarantees up to 94% of our ARD, which is \$9,462,187. This is why we have the Tier I and Tier II system. There are 2 bonuses this year including one specifically for a Domestic Violence (DV) project. Up to \$50 million is available for the DV Bonus which will provide housing and services to survivors of domestic violence, dating violence, and stalking. A CoC may apply for up to 10 percent of its Preliminary Pro Rata Need (PPRN), which for our county is approximately 1.2 million dollars. DV Bonus projects will be reviewed for eligibility and threshold requirements and will be selected based on the CoC Application score plus other criterion. The funds may be used for; O Rapid Re-housing (PH-RRH) projects. O Joint TH and PH-RRH component projects as defined in Section II.C.3.m of this NOFA. O SSO Projects for Coordinated Entry (SSO-CE) to implement policies, procedures, and practices that equip the CoC's coordinated entry to better meet the needs of survivors of domestic violence, dating violence, sexual assault, or stalking (e.g., to implement policies and procedures that are trauma-informed, client-centered or to better coordinate referrals between the CoC's coordinated entry and the victim service providers coordinated entry system where they are differen	
		and they will be funded in this competition only with FY 2018 funds (meaning no funds recaptured from	

		prior years will be awarded to the project). HUD will not permit projects that have the following characteristics to consolidate: o outstanding audit or monitoring findings; o outstanding obligation to HUD that is in arrears, o unresolved construction delays, o history of poor financial management/drawdown issues, o history of low occupancy levels, or lack experience in administering the project type, or Other capacity issues. Aside from the DV Bonus there is a regular bonus on the table in the amount of \$747,661. HUD will allow projects and CoCs to combine bonus and reallocation available funding in a single project as both new bonus and new projects created through the reallocation process have the same eligible new components: PH-PSH PH-PSH PH-RRH Joint TH and PH-RRH HIMIS SSO-CE The Grant Review Committee has not yet determined whether they will accept bonus projects for all of those areas or limit it to just a few. They will discuss that at the July 16th meeting. Reallocation: CoCs can shift funds in whole or part from existing eligible renewal projects to create one or more new projects without decreasing the CoC's ARD. CoCs may only reallocate eligible renewal projects that have previously been renewed under the CoC Program The Grant Review Committee will determine if reallocation of fund is necessary based off performance review. The Grant Review Committee will be responsible for determining all of the ranking, rating, and tiering of projects.

Pathways to Housing is an online referral system where consumers can self-report. Once the referral is received an e-blast goes out to the network and they respond if they are able to help that individual or not. New Hope Village is having an open house on July 16th. You can tour our apartments; meet our board and our staff. Barstow no longer has an emergency shelter. We are working with our city manager and our city council to see what we can do to resolve this issue.
