In September 2007, the San Bernardino County Homeless Partnership (SBCHP) was formed to provide a more focused approach to our goal of ending homelessness within the County. The Partnership consists of city governments, community based organizations, faith-based organizations, educational institutes, non-profit organizations, private industry, and federal, state, and local government.

SBCHP was developed to promote a strong collaboration between agencies to direct the planning, development, and implementation of the County's 10-year-plan to end chronic homelessness. The Partnership meets on the third Wednesday of each month at the Behavioral Health Resource Center in Rialto. The Partnership facilitates better communication, planning, coordination, and cooperation among all entities that provide services and/or resources for the relief of homelessness in San Bernardino County.

Mission Statement

The Mission of the San Bernardino County Homeless Partnership is to provide a system of care that is inclusive, well planned, coordinated and evaluated and is accessible to all who are homeless and those at-risk of becoming homeless.

COMMITTEE UPDATES		
211/CES	Gary Madden	 Since the CES launched less than 2 years ago there have been 2,755 assessments completed and 577 people have been housed. The majority went into Permanent Supportive Housing and Rapid Rehousing with some going into Transitional Housing. As of 2 weeks ago there were 126 referrals out to providers. The percentage by cities are San Bernardino 54%, Victorville 20%, Ontario 10%, Redlands, 9% and Fontana 7%. Gary provided percentages by ages as well and has collected data on race but not ethnicity. He suggested we include the CES report at all our HPN meetings. The last ICH meeting was August 15, 2018. The applications for CoC funding were presented. All 28
ICH Report	Tom Hernandez	applications were approved for submittal. The two agencies selected for the DV bonus were Lighthouse and Family Assistance Project in Victorville. The total amount to be submitted for the CoC this year is 12.4 million. The next Special ICH Meeting will be held 9/19/18, and all reports will be postponed.

Providers need to talk to their city to see if they are going to declare a Shelter Emergency Crisis.

ICH Report	Tom Hernandez	 ICH had a short meeting. Aside from reports they voted on grant review committee members for HEAP funding. Six individuals were chosen to be members of the committee. The committee received 40 applications to review and some of those applications had multiple projects.
PRESENTATIONS		
Showers for the Homeless – Refresh & Renew	Peter Vern Hoffs	While doing volunteer work in Redlands with the homeless population, one thing that kept coming up as a need was showers. Peter's faith based organization received a grant to purchase a 20 foot shower unit with 3 individual showers. On April 12, 2018 they provided their first showers. As of tomorrow (just under 7 months) they will have provided over 900. They are currently providing showers at 2 locations. Monday they will be at Holy Name of Jesus Catholic Parish on the north side of Redlands from 10:30- 12:30 and on Thursday they will be at Redlands Family Services from 8:45 to 11:30. A storage facility provides the storage and all the water and disposal needed. Everything is made possible through donations except the grant for the truck and can accept donations of cash or gift cards for Amazon, Walmart and Dollar Tree. On December 8, 2018 they will hold their first annual fundraiser. It is a fair at Smiley Park with vendors, food etc. from 4:00 to 8:00.
DISCUSSION ITEMS		
HEAP/CESH State Funding	Tom Hernandez	 Application for CESH was submitted in October. Awards should be given this month. It is similar to HEAP but related to 4 areas - RRH, flexible subsidy pools, outreach and navigation and CES. There can be agencies that will partner with each other to cover those areas. Cities have until November 16, 2018 to declare an emergency shelter crisis. HEAP must be spend within 2 ½ years and CESH must be spent over 5 years. There will be a second round of funding in approximately May or June if missed the first

Continued Discussion on Homeless College Students	Jessica Alexander	 round, depending on score. This item has been kept on the agenda to continue the discussion on homeless college students. Andre shared information regarding his involvement with Brenda Dowdy and the Homeless Youth Task Force to include local community college homeless liaisons. He has received reports from Chaffey and Valley College on how many students they are serving, what types of activities they provide for homeless students, etc. Each college has at least one full-time staff that works with their homeless and foster aged population. Recommendation from Andre is to get someone from the colleges to attend our next HPN meeting.
