Legislative Report	Chekesha Gilliam	 May31, 2019 is the last day for each house to pass bills introduced in that house with the exception of proposed constitutional amendments. Bills that did not meet the deadline are either "dead" or become 2-year bills. On June 13, 2019 the Legislature sent Governor Newsom a \$214.8 billion budget bill which now awaits the Governor's signature. Housing and Homelessness items of interest in the budget include:

I want to highlight one particular item that went before the board on May 21, 2019. Community Development and Housing brought six Homeless Emergency Aid Program (HEAP) contracts for approval. The contracts were for: City of Colton – \$400,000 City of Montclair - \$234,000 City of Redlands - \$600,000 City of Upland - \$127,825 Salvation Army - \$527,000 Morongo Basin ARCH - \$213,000

Coordinated Entry System (CES)	Maricela Manzo	 In the month of May the CES performed 289 assessments. We referred 91 households to services. 59 households were enrolled in housing programs and 26 households were housed. Our data reflect 58.6% of our assessments are recommended to Permanent Supportive Housing (PSH) housing intervention; but because we do not have inventory for those not meeting Category 1 Chronic Definition, they are referred to Rapid ReHousing (RRH) intervention. KEYS HSP Program has the highest enrollments. We will be having three CES Workshops for anyone receiving funding and use CES. These workshops are an introduction to our process, how to access CES, and how to accept referrals as a program. The third workshop is for Street Outreach teams only. The workshops will be held at our office in Rancho Cucamonga. You must sign up for the event through Eventbrite as we have limited space available. Approve the budget modification request from the City of Redlands for their Homeless Emergency Aid Program funded project	Tom Hernandez	 On June 19, 2019, the Office of Homeless Services received a Change Request from the City of Redlands (City) requesting a line item budget change of \$20,000 in the Services Category from the Activity of Street Outreach to the Activity of Other – Supportive Services Administration with no change to the total Contract amount of \$600,000 or to the number of individuals to be served of 500. The City originally forecasted the cost for Street Outreach at \$127,617 based on the projected salary costs for two part-time Community Coordinator positions each with a tentative start date of February 2019. The City's HEAP Contract was not fully executed until May 21, 2019 causing a delay in the hiring of the positions. The City Council

Approve Recommendations from the By-Laws and Membership Committee to update the Code of Conduct and add a Grievance Policy to the ICH Governance Charter	Dr. Veronica Kelley	 approved the part-time positions at their June 18, 2019 City Council Meeting. The recalculation of the salaries is now estimated at \$107,617, a \$20,000 reduction. The City is requesting the transfer of the \$20,000 from Street Outreach to Other – Supportive Services Administration, reducing Street Outreach by \$20,000, from \$127,617 to \$107,617, and increasing other – Supportive Services Administration by \$20,000, from \$0 to \$20,000. The City would use the \$20,000 to facilitate the procurement of a professional consultant to administrative requirements and compliance obligations. A Motion was made by Supervisor Lovingood to approve the budget modification. Patricia Nickols-Butler seconded the motion. All were in favor. None opposed or abstained. Motion approved. RECOMMENDATION

Authorize the Office of Homeless Services to develop a workshop for ICH Members on how to best coordinate these different funding sources and maximize the creation of units, both for permanent supportive housing and rapid rehousing that best meet the needs of our CoC.

BACKGROUND INFORMATION

On June 26, 2019, the ICH voted to establish the 2019 ICH CoC Grant Review Committee, as such, it is important that we review the goals and policies as established for the Continuum to maximize both state and federal funding.

The ICH Membership as stewards of these funds have the oversight and responsibility to set the policies and priorities for all funding sources managed. This recommendation seeks the ICH Membership's support to instruct the Office of Homeless Services to develop a workshop on how to best coordinate these different funding sources and maximize the creation of units; both for permanent supportive housing and rapid rehousing that best meet the needs of our community.

This Workshop will assist the Continuum to understand all grant cycles and timelines, including CoC, the Homeless Emergency Aid Program, the Homeless Housing and Assistance Program, Housing for a Healthy California, California Emergency Solutions, No Place Like Home and Housing program, and potentially others to determine what recommendations would best serve our most vulnerable homeless populations.
