Thanked the board for their trust in her to lead them going forward. Wants Council Roundtable to be more of a "Ripples of Hope", where we can share accomplishments, words of encouragement and ask for partnerships. The Housing Authority submitted a VASH application last week for additional vouchers, in which our county is in a good position to receive. The Housing Authority also submitted an application for main stream vouchers as well. The Desert Haven project will finish construction in mid-October.
	Sharon Green Jessica Alexander	 Expressed her concern and disappointment in this meeting. She is disheartened that the non-profits feel like they do not have trust in this board and that their concerns go unheard. Per HUD the non-profits are the only agency required to be on this board and they are repeatedly diminished. Sharon stated that she is losing confidence in this board. Congratulated Maria Razo and Thanked Supervisor Gonzales in her absence. As the Chair of Central Valley HPN she extended an invitation to Maria Razo and the candidates for Vice-Chair to attend their meeting and be a guest speaker to help bridge the gap.

Don Smith CaSonya Thomas	 Extended his congratulations to Maria Razo and acknowledged Supervisor Gonzales and her work. Don expressed his concerns and frustration with the meeting and the message it is sending to the provider communities. He stated that this body needs a balanced leadership to move forward. Wanted to remind everyone that this election is an open process, so as we go into our next meeting know that the position for Vice-Chair is open for nominations by all members of the board. 	 the call, it does not have to be just between myself and Mr. Smith. CaSonya extended her congratulations on the election of a new chair and to Supervisor Gonzales for her leadership. The County was successful, as was the Housing Authority in their partnership with the Mountain Homeless Coalition, on submitting three HomeKey projects. Two projects were for the city of San Bernardino and the third was for the mountain communities. Leveraging over \$9 million of state HomeKey funds. We are now in the documentation phase of the process which will hopefully move us from reserved to warded status. Moving Forward is up and running. Through an executive order we were able to streamline the procurement process and with that we reached out to three of our local non-profits who have been active and have the capacity to take up the charge. Keys and The Chance Project responded and said they would partner with us to help move residents out of Project Roomkey isolation and into other housing plans. CaSonya wanted to acknowledge the fact that the County is collaborating with non-profits, being innovative, and building partnerships with them on various projects throughout the county.
