Subject	Implementation of Title Change ("Intern" to "Associate") of Marriage and Family Therapist Interns and Professional Clinical Counselor Interns	
Introduction	Effective January 1, 2018, the California Board of Behavioral Sciences (BBS) shall implement changes in accordance with legislative requirements pertaining to title changes for marriage and family therapist (MFT) interns and professional clinical counselor (PCC) interns.	
Background	The title changes in the Business and Professions Code are being implemented due to concerns voiced by stakeholders and registrants that the titles may not be an accurate representation of the registrants' post-master's degree status.	
Change	The title changes for MFT and PCC interns are as follows:

Change, cont'd	<i>Note</i> : Abbreviations and derivatives for the new titles are not recognized at this time and therefore prohibited; only the new titles may be used. Titles such as "Marriage and Family Therapy Associate", "MFTA", "Professional Clinical Counselor Associate", or "PCCA" are not considered acceptable titles, and will not be recognized by law. Should the BBS issue approved abbreviations, DBH will provide notification.	
Adherence to Regulations	 MFT and PCC registrants shall adhere to the following regulations: Continue using the title "intern" until January 01, 2018, when they t must begin using the title "associate." Beginning January 1, 2018, all printed names and signatures of I registrants and PCC registrants, must adhere to the new titles. Interns and trainees must continue to provide disclosure to consun prior to performing services. When ordering business cards: Advertising requirements must be followed, and Supervisors are mandated to be listed on all business cards for licensed positions, per department policy. Note: The titles for MFT trainees and PCC trainees, who are graduate degistudents and do not register with BBS, will not change at this time, addition 	
	Registered Associate Clinical Social Workers are keeping the title "associate", and are also not affected by this change.
