CHAIRPERSON'S REPORT

Chair Caffey shared that she presented to Chaffey Unified School District students on Because You Matter. This is in support of the recent legislation requiring schools to provide suicide prevention tools. She has continued to attend the California Behavioral Health Planning Council meetings and provide Youth Mental Health First Aid trainings to High Schools in the Fourth District.

Commissioner Michael Grabhorn shared that he participated in the Department of Behavioral Health (DBH) Day Reporting Center and Criminal Justice site visits.
