H. Chair's Report	Chair, Dr. Monica Caffey	Chair Dr. Caffey was not present to provide a report.
I. Commissioners Report(s)	Michael Grabhorn	 Met with City Council, discussed homelessness in Victorville and High Desert, attended District Advisory Committee (DAC), explained Pastor Mark Graham will talk more about that, attended the Co-Occurring Disorder Subcommittee, and attended the California Association of Local Behavioral Health Boards and Commissions (CALBHB/C) Quarterly meeting.
	Pastor Mark Graham	 Stated they are known for working with the re-entry community, starting to work with Pre entry with Mental health issues, intervention approaches, especially juveniles who

	mentoring and micro credentialing, teaching critical thinking, resiliency, creative problem solving and interculture fluency. The students receive a certificate after each segment is completed. Mental Health counseling is available for students who may be struggling at home or socially. 4/12/23 he attended the State of the District for Victor Valley School Union District. On 4/20/23 met with the Superintendent of the District and started preparing for 5/11/23 working meeting with Dr. Carl Coles to begin going into the schools to implement this program. Became a Narcan distribution center, will hand out 48 Narcan packets, show a training video to educate people who have family members who are addicted on how to use Narcan if that becomes necessary. Invited to become part of the District Attorney County Commission looking at how DA processes cases; this will help with advocacy work. Pastor Mark Graham has been going to court helping individuals who are justice involved whose mental health have been the catalyst for crime they have committed. These individuals receive an assessment, collaborating with Public Defender and District Attorney's offices to determine if there is an alternative to incarceration for these individuals to get treatment for victimless crimes. On 4/19/23 DAC meeting- Dr. Wesly Wilson from Victor Valley College presented on Justice Involved efforts of the college. There are over 300 students involved in this program. Studies show that when a person is incarcerated, and education is introduced recidivism is reduced by 30-40%. Grief program continues every Tuesday at 7:00 for individuals who have experienced loss, which is affecting their mental health.
Dr. Valerie Samuel	 Attended Healthy Rancho Cucamonga Teen Summit focusing on Mental Health. Attended CALBHB/C Quarterly meeting and Orientation for new commissioners.
Allie Mink	 Presentation to Lutheran Social Service for permanent housing for individuals with cooccurring mental health and additional conditions aimed at formalizing discussions of mental health and conditions as well as reducing stigma around treatment options. Worked with Upland Unified School District gave resources for their Parent and Student Mental Health presentation for May Mental Health month, working with Citrus Valley along the same lines.
Bill Miller	 Stated his main purpose for joining was to present the paradigm change to the way mental health is presented to schools. Has been working for about 5 years on a presentation to get schools to allow teaching mental health. Would like this to be a nation-wide project but realize this must start on a small scale such as a single district or school. He stated he feels mental health programs are fragmented and need to be more centralized.
Dr. Akin Merino	 Welcomed new commissioners and thanked Pastor Mark Graham for all his work. Last month she focused on two Domestic Violence workshops: the first was general,

		discussing gender-based violence. There was then a request for faith-based domestic abuse training. This was with a group of pastors and church workers. Stated she will keep the commission posted on how these progresses. Substance abuse training for inner city workers, focusing on opioids. Part of the evaluation for the full services partnership for the county. DAC meeting had several conversations about staffing and access, many questions answered in executive session. Invited all to attend next DAC meeting the third Wednesday of each month Will be keynote speaker at 35th annual APS conference.
	Jennifer Spence	 Attended DAC and is inviting the community. Working with Churches to reduce stigma around mental health.
	Lynn Summers	 Asked for a moment of silence for family members across the nation who have been affected by gun violence. Worked with the Department of Aging to get seniors out in the community now that Covid restrictions have ended.
	Veatrice Jews	 Attended a wellness presentation by Dr. Hougen at Rialto School District. This is important to her as she was involved in church programs many years ago and realized students need help right in the moment such as intervention and preventions. The DAC meeting had a presentation by Andre Bossieux from the TAY center, which was highly successful.
	Gil Navarro	• He attended the DAC meeting where Andre Bossieux presented, shared a personal story about a young lady who he helped get assistance at the TAY center years ago who continues to do well. Shared an article from the Surgeon General titled "Kids Declining Mental Health is The Crisis of Our Time", he stated mental health support is reaching a peak priority. He has found when students have academic deficiencies that mental health is part of students challenges to being successful, would like schools to provide mental health resources when needed. The goal is to get a student wellness center at each school site. Attended San Bernardino City Unified School District's Board meeting; promoted cultural competency for staff and students as he heard of some negative remarks against African American students. Board member wants to bring back the initiative that racism is a public health crisis. Directed the board to obtain cultural competency training from the department of behavioral health, Quoted Pastor Mark Graham "San Bernardino County African American Students are 15% of the demographics but 60% of students disciplined." Waiting for the school district to contact DBH to set up trainings.

He was advised that anyone can suggest topics for Innovation projects. Vice Chair Navarro asked for clarification of the term "Dually credentialed". Dr. Frausto provided an example for clarification. Vice Chair Navarro also asked for clarification on why a student may have been refused service based on the severity of their mental illness. Dr. Frausto advised "Tiers" are mostly used for adults. Commissioner Summers asked where patients come from such as the emergency room or other sites. Dr Frausto answered patients come from multiple locations and the clinic discussed in the integrated clinic presentation will be located in Apple Valley.
