Please be advised that the County of San Bernardino, Department of Public Health, Division of Environmental Health Services – Local Enforcement Agency (LEA) received and approved a Registration Permit Tier for a Medium Volume Transfer/Processing Facility (MVTF) for PreZero Recycling Services Medium Volume Transfer Facility.

The LEA is certified by the California Department of Resources Recycling and Recovery (CalRecycle), to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active transfer stations.

Description of Project and LEA's Determination

PreZero Recycling Services Medium Volume Transfer/Processing Facility is located at 170 North Turner Avenue, Ontario CA, 91761. On February 14, 2020 the LEA received, from PreZero US Services, LLC, Inc., the official submittal of an application for a

Registration Permit in a CIWMB Form 83(rev. 12/96). The submittal for a Registration Permit as a MVTF will allow PreZero to receive and process up to 99 tons per day of dry recyclable material, organic material and some municipal solid waste including putrescible and non-putrescible commercial non-hazardous waste.

Activities at the PreZero Recycling Facility will include unloading of vehicles, moving, sorting, processing, load checking, loading of transfer vehicles and transporting recyclable, organics and some MSW and other permitted materials from the Facility for final disposition off site.

The following are the Facility's operating hours:

- Receipt of Material: Monday - Friday 6 AM to 10 PM, Saturday and Sunday 6 AM to 6 PM
- Transfer of Material Off-Site: Monday - Friday 24 hours/ day, Saturday and Sunday 6 AM to 6 PM
- Processing of Materials: Monday - Friday 6 AM to 10 PM, Saturday and Sunday 6 AM to 6 PM
- Maintenance: Monday - Friday 24 hours/ day, Saturday and Sunday 6 AM to 6 PM

PreZero Recycling Services Medium Volume Transfer/Processing Facility shall follow all minimum standards applicable to it, as set forth in Title 14, Division 7 of the California Code of Regulations (CCR), including but not limited to the following:

- Title 14, Division 7, Chapter 5 Article 3, (Regulatory Tier Requirements) and
- Title 14, Division 7, Chapter 3 Articles 6.0, 6.1, 6.2, 6.3, and 6.35 (Transfer Processing Facility Regulatory Requirements)

The LEA accepted the application as complete and correct and approved the facility to operate as a MVTF on March 13, 2020.
