



# Bloodborne Pathogens Exposure Control Trainers

Approved by San Bernardino County

The Safe Body Art Act requires that Bloodborne Pathogens Exposure Control Training be conducted by a person or persons who are knowledgeable in exposure control and infection prevention in the body art setting, and who are approved by the local enforcement agency (LEA). In San Bernardino County, the LEA is the Department of Public Health, Environmental Health Services (EHS). At minimum, the training and training materials shall be specific to performing body art and consist of not less than two (2) hours of instruction. Further requirements can be found in the [California Health and Safety Code Section 119307](#). EHS has approved the following trainers for Bloodborne Pathogens Exposure Control Training:
