Please be advised that the County of San Bernardino, Department of Public Health, Division of Environmental Health Local Enforcement Agency (LEA) received and accepted a Report of Facility Information (RFI) amendment to the Joint Technical Document (JTD) for the Barstow Sanitary Lanfill. The LEA is certified by the California Department of Resources, Recycling and Recovery (CalRecycle) to enforce state laws and regulations at solid waste sites within the County of San Bernardino, including all active and closed landfills.

Description of Project and LEA's Preliminary Determination

The Barstow Sanitary Landfill is located at 32553 Barstow Rd. in Barstow, CA 92311. On September 9, 2020, the LEA received, from the operator of Barstow Sanitary Landfill, a Solid Waste Facility Permit (SWFP) application package to amend the JTD.

The changes include the following:

- Updates to language within the JTD to reflect changes in the compostable materials handling operations and the use of processed green material as alternative daily cover (ADC) at the site. The change in language makes diversion of and processing of compostable materials optional. Green material can still be used for erosion control purposes on site. Green material continues to be an approved ADC for the site.
- Updates to Section B.3.1 to include changes made to ancillary facilities since the last 5 year permit review including the completion of Granular activated Carbon (GAC) treatment system.
- Updates to Section B.3.1.6 to reflect the construction of the GAC treatment system and to remove wording indicating the GAC is proposed.
- Updates to Section B.4.4.4 to include more detailed description of potential operational changes during periods of high winds.

The LEA finds that the proposed changes are consistent with all applicable certified and/or adopted CEQA documents, is consistent with State Minimum Standards, and does not conflict with the terms and conditions in the current solid waste facilities permit. The LEA accepted the amendment on October 9, 2020
