

Documents Required for Enrollment

- **Verification of Age** - Items for verification of births; Birth Certificate, Life Certificate, Medi-Cal Card, Baptism Certificate, Passport, or other documentation that confirms the child's age
- **Verification of Income** - To determine income eligibility, parents may use one of the following:
 - All W-2 forms
 - Income Tax Return (1040, 1099)
 - Public Assistance–Cash Aid
 - Pay stubs (including unemployment statements) reflecting 12 months of income for the relevant time period
- **Immunization Record**
- **Proof of Residence**
- **Verification of Need, TAD Child Care Certificate or Proof of Child Care Subsidy**
