Corrections Bureau: Increases/Variations to Calls for Service and Deputy Report numbers (DR):

In 2017, the Department implemented a new Use of Force reporting procedure, utilizing the Microsoft CRM platform. In 2018, new Use of Force reporting guidelines and polices were updated. The new guidelines amended the criteria for documenting Level II and III Use of Force incidents, which include written reports for these newly defined levels of force.

In 2014, the High Desert Detention Center expansion project (Phase I) was completed and the facility's staffing level was increased by thirty (30) additional deputy positions to manage the higher number of inmates.

During 2011 and 2012, the West Valley Detention Center implemented a pilot program within the Transportation Division that equipped their fleet with Mobile Data Computers in every unit. Consequently, every prisoner transport to and from the jail was entered into CAD as a Call for Service. This pilot program was cancelled in 2013.
