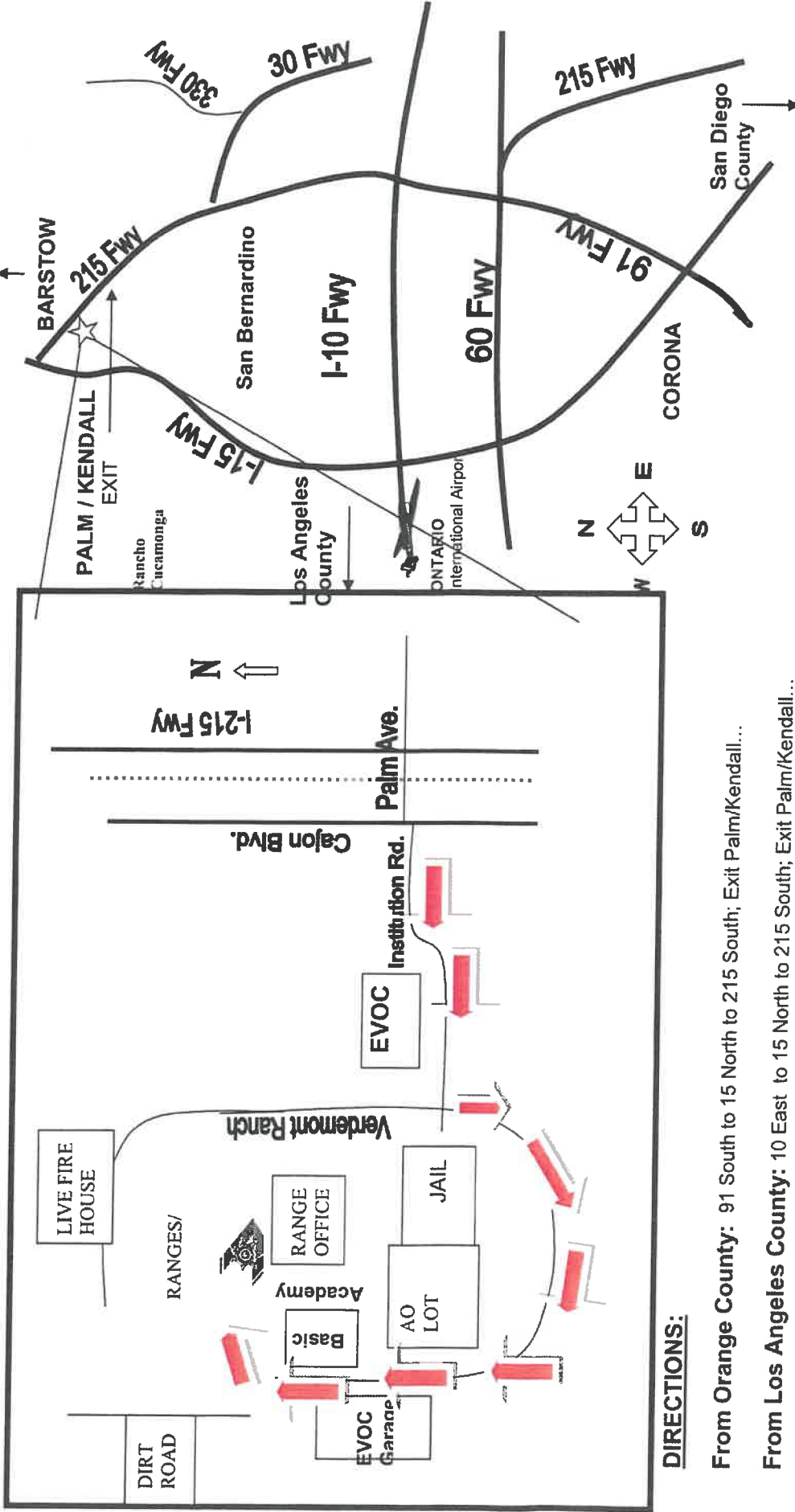

**DIRECTIONS:**

**From Orange County:** 91 South to 15 North to 215 South; Exit Palm/Kendall...

**From Los Angeles County:** 10 East to 15 North to 215 South; Exit Palm/Kendall...

...When you **exit Palm Avenue/ Kendall Drive** off-ramp, make a left and drive west. After you cross Cajon Boulevard, Palm Avenue turns into Institution Road. Continue on Institution Road to Verdmont Ranch Road and turn **LEFT**. Continue on (past JAIL and ACADEMY) parking is available up by ranges or range office.

## Back Road to Academy

(Only use when front is flooded/closed)

Go back out (n/e) on Institution Rd to the new stop sign (Institution Rd)  
Turn right on Institution Rd.  
Left on Cajon Blvd.  
Left onto Glen Helen Pkwy  
Left onto Clearwater Pkwy  
Left onto Sycamore Creek Loop Pkwy  
Left onto Oregon Ash Way  
Left onto Lapis Ln.

You will run in to a small back road to the academy. (Page 2) Stay left and take  
Verdemont Ranch Rd around to Institution Rd. After stopping! Continue through the stop  
sign following the road to the Basic Academy.
