

## BAIL BOND INFORMATION

We accept cash or bail bonds. Bail bonds need to be issued by a state approved bail bond agency. The personnel of San Bernardino County Sheriff's Department are prohibited from endorsing or recommending any specific bail bond agency.

Cash bails are processed at the Lobby of this facility. A posted cash bail must be the full amount of bail for each case. A cashier's check, in lieu of cash, can be accepted. Checks must be payable to the agency designated by the facility.

## GENERAL INFORMATION

General information may be obtained by calling (760) 530-9300 and following the prompts. Our main lobby is open 24 hours a day, 7 days a week, including holidays.

## VISITING INFORMATION

**All visits must be scheduled by phone**, the day prior to visiting, from 8:00AM to 5:00PM, Wednesday through Saturday. The visiting appointment line is (909) 887-0364. Inmates are allowed one (1) visit per day with a maximum of two (2) guests. **Visiting days** are Thursday through Sunday from 8:30AM to 7:10PM. Visitors must arrive 20 minutes prior to their scheduled time. Late arrivals will not be admitted per facility policy.

Inmates under special classifications or under disciplinary restrictions may have a different set of visiting guidelines. Please call 760-530-9300 for any questions or concerns.

## ACCEPTABLE IDENTIFICATION

All visitors 18 years and older must have a valid government issued identification card such as Department of Motor Vehicles ID or Driver's License, County or State Employee ID, Military ID and/or US Passport.

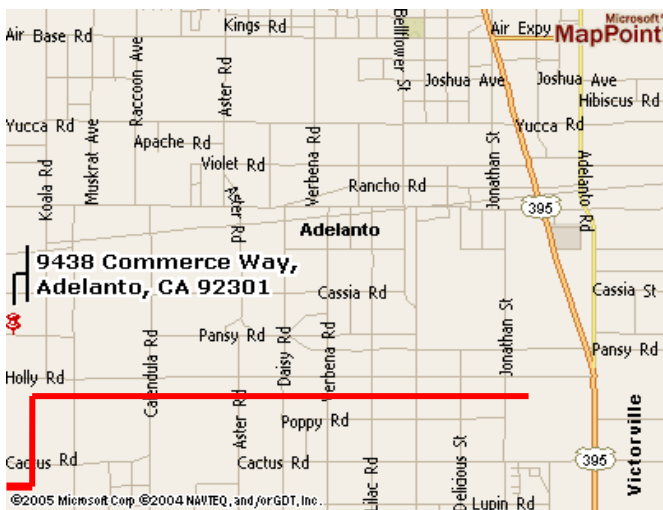
