Stage One Child Care



The Stage One Child Care (CC) program provides CC reimbursements to Providers on behalf of current CalWORKs recipients who are in an approved employment or training program.

Payments are reimbursed for CC services provided and are paid directly to the Provider.

The Stage One CC program is funded by the California Department of Social Services.



How can Stage One Child Care (CC) help my family?

Stage One CC can help families by reimbursing most or all CC expenses when the family meets the requirements of the program. Families may be responsible for paying a small portion of the CC expense.

Can my family be eligible for Stage One CC?

Your family may be eligible to Stage One CC if the Parent(s) are:

- Living in San Bernardino County,
- Receiving CalWORKs, and
- Participating in:
 - A Cal-Learn program (teen parent), or
 - An approved Welfare-to-Work (WTW) activity, or
 - Employed.

Note: In a two-parent household both Parents must be employed or participating in an approved WTW activity.

What are the age limits for Stage One CC?

Stage One CC can serve children from birth through 12 years of age. (A child's special circumstances may increase the age limit).

How can I apply for Stage One CC?

You can apply for Stage One CC by:

- Requesting CC services in a Transitional Assistance (TAD) office (see other side for locations),
- Phoning a TAD office, or
- Sending a written request to a TAD office.

What do I need to do for Stage One CC?

You will need to:

- Answer questions
- Select an eligible CC Provider
- Complete forms (Parent and Provider), and
- Return verifications (Parent and Provider)



How do I find a CC Provider?

The local Resource and Referral (R&R) agency can provide assistance with finding a licensed CC Provider to meet your family's needs.

What are the types of CC Providers?

Below are types of CC Providers, licensing requirements and Provider categories:

Type of CC Provider	Licensing Requirement	Provider Category
• Academy • Center	Must be licensed	Child Care Centers
Home Day Care	Must be licensed	Family Day care
• Grandparent, • Aunt, or • Uncle, only (No "Greats")	No license required as long as the Provider cares for no more than one unrelated family's children.	License-Exempt TrustLine Exempt
• Other relatives not listed above (great-grandparent, siblings, or cousins, etc.) • Neighbor/friend	No license required as long as the Provider cares for no more than one unrelated family's children.	License-Exempt TrustLine Registry Required
Before or after school program	No license required for Recreation Program	Exempt Center, or Recreation Program

A CC Provider:

- Must be 18 years of age or older,
- Provide a valid identification and Social Security number, and
- *Cannot* be a member of the CalWORKs family unit.

What is TrustLine Registry?

TrustLine is a registry of License-Exempt CC Providers who have been fingerprinted, received clearance of his/her background and approved by the California Department of Justice and Federal Bureau of Investigations.

If you select a TrustLine-Required CC Provider, he/she must become TrustLine approved/registered before reimbursements can be made to the provider.
