# **CalFresh**





**Transitional Assistance** 

#### What is CalFresh?

CalFresh is a benefit program which helps low-income individuals and families buy the food they need. CalFresh benefits are provided on an electronic card that is used like an ATM or bank card to buy food at most grocery stores.

### Who Qualifies for CalFresh?

Specific eligibility requirements for CalFresh consider citizenship, income and other factors. Generally, benefits are available to low-income individuals and families who are:

- U.S. citizens, or
- Legal immigrants who meet certain criteria. Recipients of Supplemental Security Income (SSI) are now eligible to CalFresh.

# What Are the Requirements for CalFresh?

To receive CalFresh benefits, eligibility requirements must be met in the following areas:

- Citizenship/Immigration status
- Income
- Residency in San Bernardino County
- Work registration
- Social Security Number

Other requirements may apply based on individual/family circumstances.





## What Are the Income Limits?

There are two income limits: gross and net. Your total income before taxes or any other subtractions is called gross income. Certain subtractions to your gross income, called deductions, are allowed. Deductions can include: housing costs, child support payments, child or dependent care payments and monthly medical expenses over \$35 for elderly or disabled people. The amount left over after these deductions is called net income.

#### **How Much CalFresh Can I Get?**

The amount of CalFresh benefits a person or family can receive is based on the size of the household, their income, and amount of deductions they have.

## How Do I Apply for CalFresh?

You can apply for CalFresh by:

- Completing an online application at www.BenefitsCal.com.
- Calling the Customer Service Center at 1-877-410-8829 to request an application by mail.
- Calling 2-1-1 to complete an application over the phone.
- Visiting your local TAD office to complete an application in-person.

Families and individuals can request Expedited Services (ES) when applying for CalFresh. Applications that meet ES qualifications are eligible to have benefits processed within three days.
