

**CalJOBS<sup>SM</sup> Activity Codes and Performance Crosswalk**

**Credential Attainment** – A participant is included in this measure if they exited from the program and were in either a postsecondary education or training program (other than OJT or customized training) OR in a secondary education program at or above the 9th grade level without a secondary school diploma or its equivalent. In addition to the activities noted below, inclusion in the measure may also be triggered by the "school status" questions in the application and closure form.

**Measurable Skill Gains (MSG)** – A participant is included in this measure if they are in an education or training program. In addition to the activities notate above, inclusion in the measure may also be triggered by the “school status” questions in the application, co-enrollment in Adult Education, Job Corps, Youth Build or Vocational Education in program entry (from application), co-enrollment in partner programs (on the activity code), activity codes closed with school status as in-school (Youth records) OR case closure created with school status as in-school.
