

## Prison to Employment (P2E) Questions & Answers

---

**Question #1**      When can P2E enrollment begin?  
**Answer:** Monday July 6, 2020

---

**Question #2**      Are individuals who have not served time in a correctional facility and has completed their parole/probation eligible for P2E Services?  
**Answer:** No, these individuals do not meeting the eligibility criteria for P2E services. These individuals can be evaluated for eligibility to other program services.

---

**Question #3**      If the participant does not have documentation to verify eligibility, can we accept a self-attestation to determine the individual's eligibility for P2E services?  
**Answer:** No, applicant statement/self-attestation is not acceptable documentation for establishing P2E eligibility. In this situation the individual will not meet the eligibility criteria for P2E and can be evaluated for eligibility to other program services.

**Question #4**      For individuals who were sentenced in San Bernardino County, can we pull up the information from the County website and use as verification?  
**Answer:** Yes, this is acceptable P2E eligibility verification.

### Question #5

We took an application yesterday (6/29/2020) for COVID 19 Supportive Services, the individual is previously incarcerated and wants training, on July 6<sup>th</sup>, can we just do the P2E Questionnaire and add the P2E effective July 6<sup>th</sup> when the application was taken and processed on June 29<sup>th</sup> or does the individual need to complete a new WIOA application?

**Answer:** Yes, this individual can be co-enrolled into P2E, as the WIOA Application is less than 30 days old from the start date of P2E services (7/6/2020). You do not need to take a new WIOA Application. The specific steps that staff will need to take to complete this action are as follows:

- Review the WIOA application, Question #44 – address in the case note
  - Have the customer complete the P2E Questionnaire
  - Collect the eligibility documentation
  - P2E is effective & eligible when all documentation is received

### Question #6

Can someone currently enrolled in WIOA be entered into P2E if eligible?

**Answer:** Please see answer to question #5

---

### Question #7

How are we paying supportive services for child care, ID, etc. when they do not accept our vouchers?

**Answer:** We can assist individuals through reimbursement. This will be the method of payment for the majority of supportive service requests/authorizations.

Parole has communicated that individuals will be released with a CA ID, please check with the individual.

We understand that reimbursement may be a barrier to this population and we suggest the following:

- If the individual did not receive an ID upon release, the parole agent can provide the DL 933, for a reduced-fee state ID
  - If the individual is receiving public assistance (*CalWORKs, CalFresh, or General Relief*), refer the individual to TAD to obtain the DL 937 for a reduced-fee state ID
