Policy

It is the policy of the Department of Behavioral Health (DBH) to collect and enter intake, discharge, and annual update data about recipients of substance use disorder (SUD) treatment services via the California Outcomes Measurement System (CalOMS), and report this data monthly to California Department of Health Care Services (DHCS), with an error rate of less than five (5) percent.

Purpose

To outline the requirements of DBH Substance Use Disorder and Recovery Services (SUDRS), DBH Information Technology (IT), and SUD contract providers to adhere to DHCS CalOMS data collection and submission standards.

Entering CalOMS Data

Staff who enter CalOMS data into DBH's Behavioral Health Management Information System (BHMIS) are responsible for protecting the integrity of the data by recognizing errors made by intake personnel, and correcting the errors prior to entering into the BHMIS. The following are prerequisites to entering CalOMS data into the BHMIS:

- Complete training with DBH IT regarding BHMIS access and data entry, and
- Demonstrate knowledge and understanding of the CalOMS TX Data Dictionary and CalOMS TX Data Collection Guide, as evidenced by ability to recognize and correct documentation errors and maintain a monthly clinic error rate less than five (5) percent.

Note: DBH and contracted providers of SUD treatment services shall participate in CalOMS informational meetings, trainings, and conference calls as directed by SUDRS Program Manager II (PM II)/designee.

Determining Root Cause of Errors

Clinic Supervisor/designee shall review each month's CalOMS errors to determine the root cause of each error and discuss the findings with the staff who committed the error in order to:

- Determine reasoning for inaccuracy;
- Provide correct data with explanation of determination, and
- Decrease future occurrences by identifying and educating staff members who report incorrect CalOMS data.
